<u>Action:</u> David Barton moved, seconded by Michelle Skinlo and carried unanimously that the Emergency Executive Director Succession report be approved and recommended as stated and as is current practice: *In order to protect the Board from sudden loss of Executive Director services, the Executive Director may not have fewer than two other designees familiar with Board and Executive Director issues and processes.*

It was noted that the Past President should be included in the list of officers who are to receive a monthly copy of the Executive Director's calendar.

IASB Pension Plan

The Executive Director reviewed the current Employee Pension Plan.

The Illinois Association of School Boards Employee Pension Plan is a defined contribution self-directed plan. Monthly contributions are made by the employer at 7.5 percent of salary during the plan year (December 1 to November 30). An additional contribution of 4.25 percent is made on annual plan year salary that exceeds the FICA limit in effect at the beginning of the plan year. The Plan has three trustees identified by their positions: IASB Executive Director, Chief Financial Officer and Treasurer.

Employees become vested in the plan following their second year of service. The vesting schedule results in full (100 percent) vesting after the sixth year of employment.

IASB Conference Committee Report

2004 Conference Co-Chairs Wesley Stellhorn and Donna Cech reported there had been an additional 60-80 onsite registrations, the Chicago Schools Tour had gone well and staff had done an exception job in making it run smoothly and ninety-nine percent of the exhibitors were happy and felt the attendee traffic excellent.

The Executive Director noted: Approximately \$20,000 had resulted from onsite registrations. The bookstore was right on target with the last two years. Panel topics would be more closely monitored in future years to omit some of the topic duplications. Many positive remarks had been expressed regarding the Comiskey Room and the inclusion of the State Board of Education members in this format. It appeared attendees were pleased with the new conference program book format. NSBA President George McShan was present and participated in a large portion of the program events and was favorably impressed with the programming and execution of the entire conference.

Ray Zimmerman suggested that the program booklet have a few blank pages for jotting down notes.

Delegate Assembly Discussion. A discussion ensued in response to Mark Metzger's comment that he was surprised at the low attendance of the Delegate Assembly and he requested that the Executive Director touch on what might be done to increase the participation at the February Board meeting. Cheryl Jackson suggested sending a letter to some of the boards that did not register a delegate. Fred Clatfelter felt he would rather have interested low numbers of people actively involved than a lot who were not interested in participating. Christy Coleman suggested looking at a time that might not be as competitive with other events. Tom Hannigan wondered if it might be a good idea to have the Delegate Assembly on Friday evening and that he would rather have strong participation than strong attendance. Michelle Skinlo stated her first Delegate Assembly was held on Friday evening and it was in competition with Board and supplier receptions/dinners. Skinlo suggested considering a Thursday evening Delegate Assembly. Debora McCleary wondered if panels/panel topics could be retimed to not compete for people's participation. Roger Pfister advocated keeping the same timeframe and recognizing those who did attend at division meetings with something more than a pin to show the Association's appreciation for them being present. Pfister did not think the panels should be messed with and a night session would cut participation in halfthe current timing is exactly where it need to be. Fred Blue suggested perhaps there should be an alternate to the designated district delegate. The Executive Director noted that staff really emphasized participation at the division meetings, but many candidates were running for re-election and almost everyone who said they would vote on HB750 were defeated for election. A neighboring state association staff member attended the Delegate Assembly and remarked at how well it was organized and conducted. NSBA President George McShan commented that the Illinois Delegate Assembly was better than any state he had attended.

President Zimmerman closed discussion by stating the Executive Director will check all of this out and bring a recommendation at the February meeting.

IASB Service Associates' Report

The Service Associates Executive Committee met Saturday morning, November 20, 2004, and among other business, reviewed membership applications and references and voted to recommend that the IASB Board of Directors invite Melotte-Morse-Leonatti, Ltd to become a member of the IASB Service Associates.

<u>Action:</u> Mark Metzger moved, seconded by Lowell Beggs and carried unanimously, that the IASB Board of Directors issue a Service Associate membership invitation to Melotte-Morse-Leonatti, Ltd., of Springfield, an architectural firm focusing heavily on environmental issues and industrial hygiene, doing business with Illinois school districts for sixteen years.
