

FOREWORD

July 2021

This summary of bills passed during the Spring Session of the Illinois General Assembly has been compiled to allow local school officials an opportunity to review the actions of the General Assembly and the Governor during this legislative session.

The Illinois Association of School Boards lobbying team has made every effort to identify and include in this publication any bill that affects schools. Also, please note that the synopsis of each bill is brief and may or may not encompass the full content or impact of the bill. Rather, the synopsis is designed to call to the readers' attention any proposed statutory changes and additions that may merit further research. For full meaning, it may be necessary to obtain a copy of the complete bill.

All legislation can be viewed online at the Illinois Legislative Information System website at www.ilga.gov. Statutory citations have been removed as they can be easily obtained by accessing the bill online.

The bill summaries are organized under subject matter categories arranged alphabetically as shown in the Table of Contents. In addition, two indexes are provided which may be used to identify a bill by title or number. Also included is a heading of "Last Action" after each bill description, a section labeled Gubernatorial Action Bills, and a section on Determining Effective Dates; these additions should help you determine where the bill is in the process.

BOARDS OF EDUCATION

HB 0004

Election Day E-Learning

Sponsors:

House: Mayfield

Senate: Johnson - Koehler - Van Pelt

Summary: The bill permits student instruction to be received electronically under a school district's program for e-learning days while students are not physically present because a school was selected to be a polling place under the Election Code. Also adds that a school district shall pay to its contractors who provide educational support services to the district their daily, regular rate of pay or billings rendered for any e-learning day that is used because a school was selected to be a polling place.

HB 0024 Sex Education Instruction

Summary: The bill provides that sex education course material and instruction for 6 through 12th grade must include sexting, the importance of internet safety, and identification of support personnel in the school district/community who can provide assistance and development of strategies for resisting peer pressure.

HB 0041 Special Education In-State Facilities

Summary: The bill requires Illinois school districts to offer parents of special education students, special education services provided by in-state facilities providing comparable services to out-of-state facilities. Also requires the school district to annually review out-of-state placement and offer in-state placement.

Limits a school district's use of timeout and physical restraint to be used only under certain circumstances, disallows certain restraint at the end of 2021-2022 school year, provides for certain prohibitions and information to be provided to parents.

HB 0452 Parental Notification of Specialized Service Schools

Summary: The bill requires school districts to notify parents of the existence of schools that provide specialized services for children who are deaf, blind, or who have an orthopedic impairment. It also transfers the Illinois Commission on Volunteerism and Community Service from the Illinois Department of Public Health (IDPH) to the Illinois Department of Human Services (IDHS).

HB 0577 Youth Suicide Awareness and Prevention

HB 1778 Suicide Prevention on Student ID

Summary: The bill requires school districts to print suicide prevention information on student identification cards included in student handbooks and planners, if they are provided, for grades 6 through 12.

Summary: The bill allows electronic signature and communication for labor to show interest in a labor organization petition and requires that showing of interest must occur within 12 months of petition filing. Also allows electronic secret ballot election in addition to paper ballot voting systems. Creates an unfair labor practice for employers to take any action for an employee's participation in a lawful strike.

Summary: The bill provides that if a special education student who reaches 22 years of age during a time when in-person learning/ instruction are suspended for three months or more as a result of COVID-19 the student is eligible for services up to the end of the regular 2021-2022 school year. It also requires school districts to notify parents within 30 days of the effective date of the bill.

Summary: The bill allows a student who is a victim of gender-based violence to transfer schools immediately if the student's continued attendance at the original school poses a risk to the student's mental or physical well-being or safety. It also provides that a student's disclosure of his/her status as a parent, expectant parent, or victim of gender-based violence be a mitigating circumstance in any suspension or expulsion proceeding. Many other requirements for school districts are also included affecting homebound instruction, student absences/truancy, staff training, review/revision of policies and procedures, complaint procedures, confidentiality, and student accommodations and services.

grade that includes training materials and instruction on prohibited grooming behaviors and how to report these behaviors to school authorities.

Summary: The bill requires community colleges to develop a plan to offer dual credit courses to high school students with disabilities enrolled in school districts located within the community college district. It also defines independent living skills for student transition services, requires school districts to share information about the school district's career and technical education opportunities (CTE), and requires school districts and community colleges to modify the dual credit plan to ensure access for students with disabilities with programs/supplementary aids/accommodations provided for in the student's Individualized Education Plan (IEP).

SB 0215 Opioid Litigation

Summary: The bill prohibits local governments and school districts to file or become a party to opioid litigation against an opioid defendant that is subject to a national multistate settlement unless approved by the Attorney General.

Nicotine Products Sale to Minor

Summary: The bill creates the Preventing Youth Vaping Act disallowing any person to sell, buy for, distribute samples of or furnish electronic cigarettes or alternative nicotine products to persons under 21 years and establishes a Class 4 felony resulting in 1-6 years in prison and a fine of \$25,000 or more. Additionally, the Department of Revenue may impose a civil penalty up to \$10,000.

DHS Compliance Check – Retailers Sell Nicotine Products to Minors

Summary: The bill permits the Department of Human Services (IDHS) to conduct compliance checks on retailers selling tobacco products to investigate whether they are selling tobacco, nicotine, or e-cigarette products to underage persons.

Faith Practices – History Curriculum

Summary: The bill provides that the teaching of history of the United States shall include the contributions made to society by Americans of different faith practices, including, but not limited to, Muslim Americans, Jewish Americans,

Christian Americans, Hindu Americans, Sikh Americans, Buddhist Americans, and any other collective community of faith that has shaped America.

SB 0605 Attendance Policy – Notice to Parents

Summary: The bill sets forth the elements to be included in school district policies on absenteeism and truancy and requires annual notification to students and parents.

SB 0654 Play Time – 30 Minutes

Summary: The bill provides that play time shall be for all students in kindergarten through grade five. Requires play time to be for at least 30 minutes on any school day that is five clock hours or longer in length.

SB 0692 **Coal-Tar Sealant Parental Notice**

Summary: The bill requires school districts to notify parents by telephone or written notice 10 days prior to application of coal-tar sealant. It also requires the district to obtain bids for an alternative for asphalt-based or latex-based sealant.

SB 0805 **Unused Food Sharing Program** for Needy Children

Summary: The bill requires school districts to develop an unused food sharing program for needy children. It requires school districts to incorporate the plan into the district's local wellness policy. The program requires the school district and local health department to jointly support the program.

SB 0814 **Teacher Mentoring Program**

Summary: The bill creates a new teacher induction and mentoring program that aligns with the Illinois Culturally Responsive Teaching and Learning Standards and allows school districts that already have a teacher mentoring program to utilize their program and be eligible for funding if it is modified to meet the new requirements. It also establishes a competitive grant program for principal mentoring program and ties professional growth to the areas addressed in the Illinois Performance Standards for School Leaders.

SB 0817 **Dress Code – Hairstyles**

Summary: The bill provides that a school uniform or dress code policy adopted by a school board or local school council shall not include or apply to hairstyles, including hairstyles historically associated with race, ethnicity, or hair texture.

Comprehensive Sexual Health Education

House: Lilly - Willis - Ramirez - Evans - Costa Howard **Summary:** The bill requires school districts that deliver comprehensive sexual health education to utilize a standards-based sex education course for 6th through 12th grade. They may provide age and developmentally appropriate consent education for kindergarten through 5th grade students. It also includes school disclosure, parental requests, and notice of program. Allows school districts to collaborate with public health departments to identify a point of contact for inquiries and comments about course instruction and materials.

SB 0820 Freedom Schools

Summary: The bill provides clean-up provisions from the passage of PA 101-654. For Freedom Schools, it expands the definition for those eligible to include African American students and other students of color; adds members to the Inclusive American History Commission; expands the definitions regarding advanced placement and dual-credit coursework; changes the membership of the Whole Child Task Force; and extends early intervention services for pre-k children with an individualized education program (IEP) up to the beginning of the school year of their third birthday.

20 2021 DIGEST OF BILLS PASSED

GUBERNATORIAL ACTION ON BILLS

Section 9 of the Illinois Constitution provides that every bill passed by the General Assembly shall be presented to the governor within 30 calendar days of its passage. The governor then has 60 days from that date in which to act on a bill by either signing or vetoing the legislation. If the governor chooses not to act on the legislation it automatically becomes law after the 60-day period.

Below is a chart to indicate the appropriate action that follows gubernatorial action:

DETERMINING EFFECTIVE DATES

To determine a bill's effective date, four elements are important:

- 1. Is the effective date given in the bill itself?
- 2. On what date did final passage of the legislation occur?
- 3. If the legislation passed after May 31, how many votes did it get in each chamber of the General Assembly?
- 4. On what date did the governor sign the legislation?

After you have identified these four things, the Illinois Compiled Statutes (5 ILCS 75/1), Section 10 of Article IV of the Illinois Constitution and Rules of the General Assembly establish a procedure to determine effective dates. The following is a brief description of these rules:

Bills Passed Prior to June 1

A bill passed prior to June 1 of a calendar year that does not provide for an effective date in the bill shall be effective January 1 of the following year or upon signing, whichever is later.

A bill passed prior to June 1 of a calendar year that does provide for an effective date in the bill shall become effective on that date if that date is the same as the signing date or after the signing date.

A bill passed prior to June 1 of a calendar year that does provide for an effective date in the bill shall become effective on

the date that it is signed if the effective date provided in the bill occurs before the date of signing.

Bills Passed After May 31

A bill passed after May 31 of a calendar year that does not provide for an effective date in the bill shall become effective June 1 of the following year or upon signing, whichever is later.

A bill passed after May 31 of a calendar year that does provide for an effective date in the bill and passes the General Assembly with a 3/5 majority (at least 71 in the House and 36 in the Senate) shall become effective on the date that is defined in the bill if that date occurs on or after the date of signing.

A bill passed after May 31 of a calendar year that does provide for an effective date in the bill and passes the General Assembly with a majority of those voting (at least 60 in the House and 29 in the Senate) shall become effective on June 1 of the next calendar year.

A bill passed after May 31 of a calendar year that does provide for an effective date in the bill and passes the General Assembly with a 3/5 majority (at least 71 in the House and 36 in the Senate) shall become effective on the date of signing if that date occurs after the effective date stipulated in the bill.
