

## FOREWORD

#### July 2020

This summary of bills passed during the Spring Session of the Illinois General Assembly has been compiled to allow local school officials an opportunity to review the actions of the General Assembly and the Governor during this brief legislative session.

The Illinois Association of School Boards lobbying team has made every effort to identify and include in this publication any bill that affects the schools. Also, please note that the synopsis of each bill is brief and may or may not encompass the full content or impact of the bill. Rather, the synopsis is designed to call to the readers' attention any proposed statutory changes and additions that may merit further research. For full meaning, it may be necessary to obtain a copy of the complete bill.

In locating bills of interest to you, note that the bill summaries are organized under subject matter categories arranged alphabetically as shown in the Table of Contents. **Summary:** The bill is the local government omnibus bill. The legislation contains numerous provisions addressing issues local governments at all levels have faced due to the pandemic. For school districts, the legislation contains a provision that allows bids for contracts over \$25,000 for construction purposes to be "communicated, accepted, or opened electronically".

**Summary:** The bill codifies many of the provisions previously contained in Executive Orders by the Governor, and guidance documents and emergency rules promulgated by the Illinois State Board of Education (ISBE).

The bill:

- Allows ISBE to extend school district Financial Oversight Panels up to 10 additional years.
- Removes the requirement for standardized assessments if the U.S. Department of Education provides a waiver of such.
- Defines school employees as essential workers for providing early childhood programs under the ISBE grant program.
- Provides that in the immediate two consecutive tax years following receipt of a Property Tax Relief Pool Grant the aggregate extension base (rather than levy) of the school district, for the purposes of PTELL, shall include the tax relief the school district provided in the previous taxable year.
- Allows for up to five remote learning planning days as pupil attendance days for calculation of length of school term.
- Waives the five clock-hour requirement for school attendance during the COVID-19 crisis.
- Allows school districts to utilize E-learning days for remote learning days.
- Requires that within 10 days after the school or regional superintendent receives information of a pending criminal charge against a license holder for certain offenses, they must notify the State Superintendent of the criminal charge.
- Provides authorization for remote learning, E-learning and blended delivery of education when schools are closed due to a public health emergency.
- Stipulates that creating a remote learning program does not change any current, create any new, or remove any existing employee bargaining rights.
- Makes further clarification regarding the information that must be shared with parents of special education students and their individualized education plan (IEP) that will be considered by an IEP team. It also requires a log to be kept regarding services a student receives and removes language regarding the systems of support school districts may utilize and information that can be used in evaluations. It further requires certain information regarding Response to Intervention (RTI) be provided by written notice to parents.
- Extends the expiration date for one year, allowing school districts to utilize interfund transfers.

- Provides a calculation for funding under the Evidence-Based Funding formula for school districts under an independent authority or oversight by ISBE.
- Removes work proficiency tests for career and technical educator license endorsements, eliminates school support personnel intern endorsement, and allows visiting international educator endorsement to be valid for five years.
- Authorizes automatic renewal of teachers' licenses that were set to expire June 30, 2020 for one year to June 30, 2021.
- Extends the deadline for teacher licensure students to finish the ISBE teacher performance assessment (EdTPA).
- Waives certain requirements for student teacher applicants during a public health emergency and allows student teachers to complete student teaching requirements through remote learning, and waive certain requirements for student teaching and business management internships.
- Waives student curricular mandates regarding Patriotism and Representative Government, Physical Education, graduation requirements, and others during a declared disaster.
- Disallows schools from withholding a child's report card for not submitting proof of a dental or vision exam during a declared state public health emergency.
- Allows teacher evaluations that were not finished before schools were closed for in school instruction in March to default to "proficient" for unfinished evaluations, though those teachers whose last evaluation was rated "excellent" will be evaluated "excellent" for 2019-20. It also allows a school board and bargaining representative to mutually agree, in writing, to an alternate performance rating for teacher not in contractual continued service during the declared disaster.
- Waives the timelines connected to teacher remediation plans except if the parties mutually agree otherwise in writing.

**Summary:** The bill makes numerous changes in the Election Code. Among the provisions, it makes Election Day, this November only, an official State holiday, so schools must be closed. It also allows persons 16-years or older to serve as election judges.

**Summary:** The bill codifies the Governor's Executive Order regarding holding meetings of public bodies remotely. In times of emergency declared by the Governor, school boards may conduct meetings without having school board members physically present at the meeting site. Members of the public who are present at the meeting site must be able to hear all discussion, testimony, and votes. The bill also directs the Broadband Advisory Council to study the provision of free access to broadband service by all residents of the state. Finally, the bill suspends the deadline for filing statements of economic interest until August 1, 2020.

**Summary:** The bill contains language for the omnibus labor/management bill. Provisions would allow Education Support Personnel to qualify for unemployment insurance benefits during the summer months and any vacation breaks lasting a week or longer this year. This change in the law is limited to breaks that begin and end between March 15, 2020 and January 2, 2021. School districts, as long as they are reimbursable employers, will not incur any additional costs from this eligibility expansion as the third federal stimulus package, the CARES Act, covers 50% of the cost and the remaining 50% will be spread out over non-reimbursable employers. It allows an employer to rebut with certain evidence the presumption that any COVID-19 cases are automatically due to the work environment.

**Summary:** The bill contains a provision to extend the expiration date for the ability of retired teachers who receive Teachers' Retirement System (TRS) benefits to substitute teach in a school for up to 120 days per school year without jeopardizing their pension benefits. Without the enactment of such legislation, the number of days such a retiree could work would be 100 days beginning July 1, 2020. The additional 20 days assists school districts in finding qualified substitute teachers during this teacher shortage. The bill extends the expiration date until June 30, 2021.

**Summary:** The bill contains provisions necessary to implement the state budget for Fiscal Year 2021. It provides the Governor with added discretion on state expenditures. The bill also contains a provision for a potential sweep of \$20 million from the School Infrastructure Fund to the General Revenue Fund. While the bill gives the Governor more authority, it also creates a Legislative Oversight Committee to monitor how the Governor is using this new flexibility in Fiscal Year 2021.

**Summary:** The bill contains the FY '21 state budget. For elementary and secondary education, it holds all school districts harmless to FY '20 distribution levels and adds no new tier money. New funding will be distributed in a manner that even further prioritizes low-wealth school districts. Budget line items are also held flat for Early Childhood Education Grants, Career and Technical Education Grants, and Mandated Categorical Grants.

**Summary:** The bill modifies the tax structure for proceeds from a land-based Chicago casino. In the bill enacted last year, the taxes imposed were excessive to the point that gaming institutions were not bidding on the license to open such a casino. Proceeds from a Chicago casino are a major revenue source for any new school construction program.

**Summary**: The bill extends the debt limits for the following school districts: Komarek SD 94, Berkeley SD 87, Schiller Park SD 81, Greenview Community Unit School District 200, Williamsville Community Unit School District 15, Elmwood Park Community Unit School District 401, and Maroa-Forsyth Community Unit School District 2.

**Summary:** The bill creates the CURE (Coronavirus Urgent Remediation Emergency) Borrowing Act and Fund to provide the State with needed flexibility to borrow with enhanced efficiency in urgent circumstances. It authorizes the Governor with approval of the Comptroller and Treasurer to borrow up to \$5 billion in funds from certain sources and limits the borrowing to five areas including providing funds for increased costs of State government resulting from the COVID-19 outbreak. The bill sets aside the Procurement Code requirements for selection of purchaser of bond certificates sold under this authority and allows certificates to be sold on a negotiated basis directed by the Governor.

**Summary:** The bill disallows revocation of a drivers' license for truancy. Many other revisions regarding driver's license revocation and suspension are included in the bill.

Summary: The bill changes the sunset date for Cook County seniors to waive reapplying for the senior citizen home-stead exemption to taxable years 2019 through 2023.

**Summary:** The bill allows the chief county assessment officer to approve certain homestead exemptions without application for the 2020 tax year with certain criteria. It also allows county boards, except Cook, to waive penalties and interest on delinquent property tax payments and extends deadlines for scavenger sales and tax sales during 2020.

# **GUBERNATORIAL ACTION ON BILLS**

Section 9 of the Illinois Constitution provides that every bill passed by the General Assembly shall be presented to the governor within 30 calendar days of its passage. The governor then has 60 days from that date in which to act on a bill by either signing or vetoing the legislation. If the governor chooses not to act on the legislation it automatically becomes law after the 60-day period.

# **DETERMINING EFFECTIVE DATES**

To determine a bill's effective date, four elements are important:

- 1. Is the effective date given in the bill itself?
- 2. On what date did final passage of the legislation occur?
- 3. If the legislation passed after May 31, how many votes did it get in each chamber of the General Assembly?
- 4. On what date did the governor sign the legislation?

After you have identified these four things, the Illinois Compiled Statutes (5 ILCS 75/1), Section 10 of Article IV of the Illinois Constitution and Rules of the General Assembly establish a procedure to determine effective dates. The following is a brief description of these rules:

#### **Bills Passed Prior to June 1**

A bill passed prior to June 1 of a calendar year that does not provide for an effective date in the bill shall be effective January 1 of the following year or upon signing, whichever is later.

A bill passed prior to June 1 of a calendar year that does provide for an effective date in the bill shall become effective on that date if that date is the same as the signing date or after the signing date.

A bill passed prior to June 1 of a calendar year that does

provide for an effective date in the bill shall become effective on the date that it is signed if the effective date provided in the bill occurs before the date of signing.

#### **Bills Passed After May 31**

A bill passed after May 31 of a calendar year that does not provide for an effective date in the bill shall become effective June 1 of the following year or upon signing, whichever is later.

A bill passed after May 31 of a calendar year that does provide for an effective date in the bill and passes the General Assembly with a 3/5 majority (at least 71 in the House and 36 in the Senate) shall become effective on the date that is defined in the bill if that date occurs on or after the date of signing.

A bill passed after May 31 of a calendar year that does provide for an effective date in the bill and passes the General Assembly with a majority of those voting (at least 60 in the House and 29 in the Senate) shall become effective on June 1 of the next calendar year.

A bill passed after May 31 of a calendar year that does provide for an effective date in the bill and passes the General Assembly with a 3/5 majority (at least 71 in the House and 36 in the Senate) shall become effective on the date of signing if that date occurs after the effective date stipulated in the bill.
