With the close of the 2023 fiscal year, the Association had much to be grateful for. Member retention held steady at 100%, the Association's financial health remained strong, and member response to new initiatives and content was positive.

### Highlights of IASB's Work for You in FY 2023



A full range of policy services, tools, and education is designed to support members in their policy-making roles. Most member districts (98%) subscribe to PRESS, the

Policy Reference Education Subscription Service, which includes 467 sample policies, procedures, and exhibits. Three PRESS issues were released during the year – Issue 110 (October 2022), Issue 111 (March 2023), and Issue 112 (June 2023).

A redesigned Administrative Procedures project was launched. This one-time customization project assists in developing an administrative procedures manual that aligns with directives outlined in board policy.

Online learning assists school board members in developing skills and understanding of board work, meeting state-mandated training requirements,

and keeping current on issues facing public education. A dedicated effort to train new board members after the April school board elections resulted in 1,037 new members registering for a New Board Member Online Training Bundle.

There are close to 100 online courses and webinars available to members for on-demand viewing. Webinar topics this fiscal year focused on students and learning, governance best practices, and finance and operations. A series of webinars were also geared for new school board members and another for administrative professionals.

Online course additions were an advanced OMA course and a course on trauma-informed practices for students and staff with information that is relevant to the duties of a school board member.



Workshop offerings support IASB's Foundational Principles of Effective Governance and emphasize school board leadership. Workshops are designed for the board/governance team and can be

tailored to meet each district's learning needs.

A revised workshop helping districts discuss and strategize ways to engage stakeholders to support student success was launched. The workshop, "Reflecting on Communication and Community Engagement Tactics," is one of 12 In-District Workshops.

The IASB Executive Searches service helps boards prepare for and implement a carefully planned process and procedures for selecting superintendents, assistant

superintendents, business managers, and other key administrators. Partnership with a national affiliation allows for direct connections to a national pool of candidates. IASB conducted over half (57.1%) of the searches of Illinois districts working with outside search firms



Several programs are sponsored by IASB and offered to districts through pooling or trust arrangements, often governed by the districts themselves. Sponsored

Programs include BuyBoard national purchasing cooperative, Forecast5 Analytics for analysis, Illinois Energy Consortium powered by Future Green for energy purchasing and renewable energy, Illinois Schools Employee Benefits Consortium (ISEBC) and Metropolitan Schools Employee Benefits Program for group health insurance, Illinois School District Liquid Asset Fund Plus (ISDLAF+) financial investment pool, Mid-West Truckers Association, Inc. for drug and alcohol testing, NSN Employer Services, Inc. for unemployment cost control, procurement card (p-Card) for streamlined purchasing, School Leaders Risk Management Association (SLRMA) for risk management support, SchoolGuard® school safety service, SuperEval for superintendent evaluations, and the Workers' Compensation Self-Insurance Trust (WCSIT) and Illinois School District Agency (ISDA) insurance pools.



Advocacy is critical to the Association's mission. Issues that IASB advocates are member-driven, as guided through the Resolutions Process and Advocacy Core

Values, to ensure a strong, collective voice. An Advocacy Ambassador program launched one year ago allows school board members to become more engaged and share local voice on important issues.

IASB staff monitored, supported, or opposed more than 1,000 pieces of introduced legislation impacting education during the 2023 Spring Session of the Illinois General Assembly. Legislative Reports, federal updates, and six Calls to Action were issued to members. IASB was successful at stopping numerous bills that were deemed to have a negative impact on local school boards and the students they serve.

IASB positions addressed in legislation were 1.19 (Indigenous People Curriculum), 2.29 (Fund Balances – Miller Ratio Adjustment), and 2.24 (School Safety Grant Program). To address the ongoing educator shortage, IASB initiated legislation to help school districts that are struggling to fill teaching vacancies (HB 3442, PA 103-0193).

IASB is committed to an advocacy program that

 Supports locally elected, non-partisan, and volunteer school board members in providing

- excellence in local school board governance based upon the Association's Foundational Principles of Effective Governance.
- Supports and protects adequate and equitable funding necessary to provide all students with access to an excellent public education.
- Promotes excellence in student achievement for all Illinois students and fair accountability for academic progress.
- Advocates for legislation that supports the physical and emotional well-being of students and staff.
- Supports a safe and secure learning environment for all; including, but not limited to one in which all are free from bullying, harassment, discrimination, and violence.
- Supports the Association's commitment to educational equity for every student.
- Promotes non-partisan member engagement and provides the tools to enhance advocacy efforts.



Content delivered through Association publications and audio/video formats supports board members with their local leadership. It assists the general

public with knowledge and understanding of the role of school boards. Regular updates are provided to members via electronic communication, social media, and mailings to members. Additionally, IASB's daily news clip service, "Leading News," gives readers perspective on state and local issues impacting public education.

Six issues of *Illinois School Board Journal* covered topics of student voice and civil discourse, state and national comparisons, administrator salaries, green schools, and new board member learning.

IASB published new editions of Coming to Order: A Guide

to Successful School Board Meetings and The Effective School Board Member to inform readers of school board roles and the importance of making meetings matter.



The 89th meeting of the Illinois Association of School Boards, Illinois Association of School Administrators, and Illinois Association of School Business Officials

for the Joint Annual Conference took place November 18-20, 2022, in Chicago. There were over 120 Panel Sessions offerings, with 29 being "Share the Success" district presentations. A Carousel of Panels offered an additional 32 topics. Nine Pre-Conference Workshops aimed at school board leadership and governance saw 835 registrants. A featured session, "Rethinking Our Response to School Violence," discussed how school leaders can respond to incidences of school violence.



Also new to the 2022 Annual Conference: "The Equity Immersion." Equity, Diversity, and Inclusion support for members is vital to school board leadership and the Equity Journey Continuum that measures

school progress in equity growth. Registration for this inaugural event totaled 161. Topics included social and emotional learning, race and equity in schools, implicit bias, leading equity initiatives in districts, and more.

In the fiscal year 2023 the Association prepared for several transitions, including the departure of Executive Director Thomas E. Bertrand, Ph.D. In March

2023, the IASB Board of Directors named Kimberly A. Small, J.D., as the next Executive Director. She is the eighth full-time and first woman executive director in the Association's 110-year history. Small's transition from leading Policy Services and Office of General Counsel for the Association, along with other retirements, created space for internal promotions and the welcoming of new personnel.



IASB is a member of the Consortium of State School Boards Associations (COSSBA), a national alliance of state school boards associations serving local

school districts and school board members. Illinois school board members and IASB staff participated in the Urban Boards Alliance (UBA) Symposium in September, an Association Leadership Symposium in January, and COSSBA's inaugural annual conference in April. Former IASB Executive Director Thomas E. Bertrand, Ph.D., became the first COSSBA Executive Director on July 1, 2023.


