From the **Executive Director**

This was a year of firsts for all of us. The Association held its first Virtual Summit and first virtual Delegate Assembly, which received tremendous positive feedback from members. IASB learned from those experiences what it can offer to continue to meet the needs of member districts in a remote environment. The Association's strategic plan continued to guide the work of IASB staff with a focus on the six "Es," Envision, Empower, Engage, Educate, Evolve, and Equity.

Despite the challenges brought on by the COVID-19 pandemic, IASB staff remained focused on service offerings to the 848 member school boards to achieve 95% member satisfaction with Association programming and events. In addition, IASB ended the fiscal year in a sound financial position, above the minimum mandatory cash floor established by the board of directors.

This spring we welcomed the nearly 1,200 new school board members, elected in April to begin their journeys of board service. We welcome the return to in-person meetings and reconnecting with our members face-to-face. IASB will continue to strive for high levels of member satisfaction with programs and services, as well as our events, delivering timely learning opportunities.

The following pages highlight our efforts to develop individual board members, as well as boards acting as a whole, in the competencies and confidence that will enable them to fulfill their duties and responsibilities. Through the work of the Association, boards will exercise effective leadership given the resources entrusted to them by the community.

IASB represents over 99% of Illinois public school districts through the work of nearly 6,000 school board members advocating on behalf of approximately 2 million public school children and local taxpayers since 1913.

FY21 Measures of Success

A snapshot of the important work of the Association during the 2021 fiscal year (July 1, 2020-June 30, 2021)

Since the pandemic forced the virtual delivery of member services, IASB launched over **94 virtual events and workshops**, including webinars and Division Meetings attended by over 7,000 individuals. These virtual offerings were complimentary to members and designed to keep board members up to date on trends and current issues impacting public education. In FY21 IASB rolled out **new content for best practices on effective governance**, including the Trust Edge: Leadership Training for Board Teams in-district workshop, a social-emotional leadership webinar series for school board members, and three webinar topics on collective bargaining.



Updated tools and resources to guide new board members included a Roadmap to Success for their first year. IASB provided courses to satisfy mandatory **new board member training** and introduce new school board members to services and support provided by the Association. Nearly 800 new school board members registered for IASB's New Board Member Online Training Bundle, three courses to begin the journey of leadership and learning. Approximately 1,200 newly elected board members were registered in the Association database to receive member benefits by the end of the fiscal

year. A "welcome kit" mailed to individual new board members provided key resources, including an introduction to the work of boards of education in Illinois, a list of Open Meetings Act exemptions, and the IASB Guide to Member Benefits.

Over 7,000 bills were introduced in the first year of the 102nd General Assembly and IASB staff monitored, supported, or opposed more than 700 pieces of legislation related to public education. The magnitude of this number of bills required IASB to call on members to show the power of their advocacy. IASB launched a grassroots advocacy platform to allow individuals to efficiently connect with legislators to tell their stories. Nearly 8,700 actions were taken through IASB Calls to Action, and the Association was able to successfully block a forced consolidation measure from passing the House of Representatives.




Growth of IASB policy subscriptions and one-time services continued in FY21. While districts focused on COVID-related changes in their districts, IASB supported the increased demand for one-time fee services, conducting 140 in-district meetings for Policy Manual Customization and Administrative Procedures Projects. This correlated to higher subscriptions to IASB's full-maintenance policy update service (PRESS Plus), because for a board to subscribe to PRESS Plus, it must have an up-to-date policy manual. By the end of FY21 the number of districts subscribing to PRESS Plus exceeded the rate of regular PRESS subscriptions. To support boards in their policymaking role, IASB staff provided 109 one-on-one training sessions to PRESS Plus subscribers and member webinars with each new PRESS Update issue.


At the beginning of the fiscal year, a sixth "E" (Equity) was added to the Association's strategic plan to prioritize the Association's commitment to initiating, advocating for, and supporting efforts to ensure equity, diversity, inclusion, and racial justice within IASB, its membership, and PK-12 schools. Unequal access to educational opportunity along lines of race, class, and other aspects of identity has deep roots in American history and contributes to inequitable access to educational opportunity. The Association saw continued interest from members for the in-district workshop Equity: An Educational Imperative. IASB finalized its internal plan to guide staff work and examine practices supporting equity, diversity, and inclusion. This also included the appointment of staff to lead equity services.

Delivery of timely and meaningful content via electronic methods was critical in the remote environment IASB staff and members were operating in. Website interactions spiked as new webinar offerings, guidance, and news were released to members. IASB leveraged technology to livestream webinar events and produce over 150 videos to inform and educate. The most-viewed video recording was "Elections: How to Navigate Running for School Board" with 736 views. Monthly web sessions averaged 27,000 a month, a 59% increase from the benchmark established one vear ago, and pageviews surpassed 914,000. IASB utilized social media to connect with members and engage with its 4,687 Twitter followers and 1,575 Facebook followers.
