LOCATION — Pecatonica is a village in Winnebago County, Illinois. It is a rural area, approximately 15 miles east of Rockford, Illinois. The population was 2,195 at the 2010 census, up from 1,997 in 2000.

The Pecatonica School District is located in the quiet and well-kept Village of Pecatonica, population around 2100. The village is nearly equidistantly located west of Rockford, east of Freeport, and south of the Wisconsin state border. The district comprises the town of Pecatonica, Westlake Village and rural areas of both Winnebago and Stephenson counties. The Pecatonica River marks the village's northern border and several Winnebago County forest preserves are within close proximity, providing recreational and educational opportunities. The school district plays a significant role in the community and is very well supported.

CURRICULUM — Pecatonica School District prepares students for their futures. The curriculum is coordinated and emphasizes academic achievement. Pecatonica students have consistently excelled on state mandated assessments. Numerous academic excellence awards, Bright Star Award, National Blue Ribbon School, WorldWide Youth Science and Engineering State Championship are recent recognitions. The district utilizes NWEA MAPs, SuccessMaker, SAT assessment series.

Technology influences all aspects of the district's curriculum. The Technology Director and technology department ensure the curriculum is supported. Each classroom contains a SmartBoard or SmartPanel. Over one thousand chromebooks are distributed to the students and staff. The district is a Google school.

The district provides vocational opportunities to students through the industrial arts classes and agricultural classes. The district is a member of CareerTec vocational cooperative and Winnebago Special Education Cooperative.

An outdoor curriculum is available through programs at the nearby Illinois Conservation Foundation property, including Timbernook and Environmental Education.

SPECIAL SERVICES — The district operates a fleet of fifteen school buses. There are eleven regular routes, one vocational route and three special education routes. Transportation is supervised by the Transportation Director. Each building provides hot lunches under the direction of our food service director. The buildings are monitored by our maintenance staff and kept clean by a well trained and equipped custodial staff.

FACILITIES — Pecatonica Elementary School – EC through 4th Grades. Pecatonica Community Middle School – 5th through 8th Grades. Pecatonica High School – 9th through 12th Grades. **TRANSPORTATION** — The school district leases school buses. The district employs a transportation director and approximately 25 bus drivers. The district has 11 regular routes, 2 Career Tech routes and several special education transports.
