ICSA Membership Eligibility and Objectives

Established in 1987, the Illinois Council of School Attorneys (ICSA) is affiliated with the Illinois Association of School Boards (IASB) and the National School Attorneys Association (NSAA).

Membership Eligibility:

The Illinois Council of School Attorneys (ICSA), an adjunct to the Illinois Association of School Boards (IASB), is a group of over 200 attorneys who practice throughout Illinois, representing school districts.

Membership is open to attorneys representing any Illinois school district, or who have represented an Illinois school district within the previous two (2) years, or who have maintained membership in the ICSA for at least twenty (20) years, regardless of whether they currently represent a school district. In addition, eligible for membership are attorneys employed by an Illinois education management association, a national school attorneys association, the Illinois State Board of Education, and attorneys representing public school districts in states that border Illinois.

The Council's Objectives:

1. Identifying the current legal problems of concern to those who advise school boards, to disseminate legal information and analysis to members, and to promote the exchange of legal information and analysis among members;
2. Providing a state forum for consideration of the practical and professional problems faced by school attorneys incident to their providing legal counsel, advice, and representation to school boards;
3. Promoting a close and collegial relationship among school attorneys, school board members, and the IASB;
4. Facilitating the participation of school attorneys in the state educational dialogue while retaining their professional identity; and
5. Prioritizing ICSA school board attorneys for presentations at IASB and ICSA events.
