ANNOUNCEMENT OF VACANCY

The Board of Education of Woodridge SD 68, Woodridge, Illinois, is seeking qualified applicants for the position of Superintendent. The Board wishes to select a superintendent who will begin work on July 1, 2027.

The Board expects to offer a salary in the range of \$180,000 - \$240,000 and a competitive benefits package including sick days, vacation days, personal days, health insurance, dental/vision insurance, life insurance, TRS/THIS contribution, and professional dues. It is anticipated that the total compensation package will be based on successful experience and education. It is expected that the initial contract will be for a multi-year period, as authorized by Illinois statutes.

LOCATION – Woodridge is a village in DuPage County, Illinois, with small portions in Will and Cook counties, and a southwestern suburb of Chicago. The village is just north of the I-55 junction with IL-53. Located 25 miles west of downtown Chicago.

SPECIAL SERVICES — Woodridge School District 68 offers a full continuum of Special Education services for students with disabilities. Special education is instruction and related services provided by special education personnel or by a general education program that has been modified through the use of special education support services, supplementary aids, or other special programming.

Woodridge School District 68 follows the state and federal laws that establish criteria for special education eligibility. The federal government recognizes 14 categories under which children may qualify for special education. These disabilities include: autism, deaf-blindness, deafness, developmental delay, emotional disorder, hearing impairment, intellectual disability,

multiple disabilities, orthopedic impairment, other health impairment, speech or language impairment, traumatic brain injury, and visual impairment.

FACILITIES — Edgewood Elementary - Preschool through 6th grade, Goodrich Elementary - Preschool through 6th grade, Jefferson Jr. High - 7th and 8th grade, John L Sipley - Preschool through 6th grade, Meadowview Elementary - Kindergarten through 6th grade \, William F. Murphy - Kindergarten through 6th grade, Willow Creek - Kindergarten through 6th grade.

TRANSPORTATION — All students in kindergarten through eighth grade are eligible for bus transportation if they live one mile or more from the school building they attend, or if they must cross an IDOT-approved Serious Safety Hazard to get to school. A special "pay rider" transportation program, as space permits, and using only existing stops, allows children who reside under one mile to be bused, provided a fee is paid by the parent or guardian. Students not eligible for bus service are not permitted to ride the bus to a friend's house, a relative's house, a babysitter's, etc.

Woodridge 68 contracts its regular student transportation services with First Student, Inc.

FOOD SERVICES — District 68 has subcontracted with Quest Food Management Services to provide food service operations across our schools.

GENERAL INFORMATION ON THE DISTRICT AND AREA

COLLEGES/UNIVERSITIES — Several colleges and universities are located near Woodridge, IL, offering convenient access to higher education, with options for on-campus and nearby student housing. Key institutions include Benedictine University (Lisle), North Central College (Naperville), College of DuPage (Glen Ellyn), and Lewis University (Romeoville), all within roughly 10–20 minutes.

INDUSTRY — Woodridge, IL, boasts a robust industrial sector centered on over 13 million square feet of warehouse space (e.g., Internationale Centre) and a competitive, growing housing market with a median home price around \$438K, which rose roughly 9.4% in early 2026. Key industries include logistics, manufacturing, and corporate headquarters.
